We had 21 delegates which was more than any other state except for the host state, Texas! Ed Rigel, Sr. and Bob Sapp were chosen Minute Men, the most prestigious and highest award presented by the National Society.

Dr. Rigel was chosen "Color Guardsman of the Year." Such recognition is given to the Color Guardsman who is deemed best representative of Color Guards and the best example of service to the ideals of the Sons of the American Revolution by his service as a color guardsman. A significant award when Ed was selected out of 36,000 members eligible to serve in the Color Guard!

The Georgia Society is well recognized for the service of its members at the National level and each of the individuals named are congratulated and thanked for representing the Georgia SAR so well!

We also thank President General Larry Guzy, 2017-18, and first lady Karin for rendering outstanding leadership and service at the National level this past year. Both represented Georgia well. President General Warren Alter, Arizona society, was elected President General for 2018-19 at this Congress.

Also, at Congress, four Georgia compatriots (Thomas Chrisman, Jack Dugger, Loyd Lewis, Jr. and Alton McCloud) received Liberty Medals and 16 compatriots received OLC for recruiting 10 new members.

NSSAR "Partners in Patriotism Certificates" were awarded to Chapter Presidents, George Wheeless (Casimir Pulaski), Don Bullock (Marquis de Lafayette), Steve Hinson, Sr. (Marshes of Glynn) and John Flikeid (Robert Forsyth) for their chapters' work with veterans and participation in Wreaths Across America. NSSAR Grave Marking Medals for participation in 15 grave marking events were presented to Wayne Brown and Emil Decker and OLC's to Allen Greenly and Jay Guest.

Jamie Ruff, Jr. of the Piedmont Chapter received the NSSAR Thomas J. Bond Memorial. Photography Award (Certificate & cash award) for the best photograph depicting the spirit of patriotism.

Congratulations to these compatriots. Georgia was also recognized for work with the C.A.R. and participation in the American Poster Contest, SGT Moses Adams Brochure Contest, Rumbaugh Oration Contest, Knight Essay Contest, Eagle Scout Scholarship Competition and ROTC/JROTC Contest.

Status of applications received as of 30 June 2018 is as follows:

Applications received for review were 149 of which all but thirteen are reviewed and seven are to be mailed. As of 30 June 2018, 126 applications were sent to NSSAR and 20 applications were pended by state registrar. Three of which was returned to applicant. Sixty-five applications have been approved by NSSAR.

The second quarter 2018 statistics are as follows:

91.3 % applications reviewed

84.6 % applications sent to NSSAR

14.7 % applications pended by State Registrar

It is noted that about 50% of the applications received are supplementals.

Trustee Report of the Annual Congress, Houston, TX July 11-18, 2018

Trustee Meeting Sunday July 15th

PG Guzy called the meeting to order at 9:30 am on July 15, 2018 with an opening Prayer. It was determined that a quorum was present for the continuance of business and the meeting went forward.

PG Guzy called on all the former PG's to make opening remarks.

PG Guzy called on any Vice President Generals and Trustees that were present and not sworn in at the National Congress in July to stand and be sworn in. There were several.

PG Guzy announced RFP for the website and the Member Database generated five new bids. The ExComm had tasked the IT committee with an evaluation of all bidders. The IT Committee wrote a letter to the ExComm recommending that the SAR begin a long term relationship with one company. The matter was tabled by the ExComm committee and the IT Committee was tasked to do a full evaluation and the matter would be brought up at the Fall Trustee meeting. It was reported that the code of the current website is good, it just need a lot of fixes. It was also reported that the membership database was

PG Guzy announced that the Funds Management Agreement between the SAR and the SAR Foundation was withdrawn from consideration so that the new Chancellor General could make tweaks to the agreement. This agreement cannot be brought back until the 2019 Congress.

PG Guzy called on the Chairman of the Budget Committee, William Lee Popham, Sr. to present the budget status. Chairman Popham reported that there were only five months of expenses shown in the budget to actual. The annualized 2018 budget currently shows an increase of \$7,100 of Revenues less expenses. He also reported that the 2019 budget showed a positive \$1,500 in Revenues less Expenses. The 2019 budget will be presented to the Trustees at the Fall Leadership meeting. PG Guzy reported that the ExComm had been negotiating an agreement with a cell tower company to place a cell tower on the roof of the headquarters building. This agreement called for no cost to install or maintain the cell tower by the SAR. The projected income from the cell tower would be approximately \$3,000 per month. A motion was made to allow the ExComm to sign contracts for the cell tower. The motion passed.

A total of five motions on the website and Member Database were made from the floor. The first motion was to negotiate a long term contract with Crosby Interactive. There were no cost projections given. A motion was made to close debate on the first motion, the motion carried. The motion to negotiate a long term contract with Crosby Interactive failed. Motions 2-5 became moot. The meeting was adjourned.

Congress July 16 - 18, 2018

PG Guzy called the meeting to order at 9:04 am with the Invocation and pledges.

about to fail, but the new IT Director has made upgrades to the current database and it will not fail.

- PG Guzy called on several organizations to bring greetings. The Texas Society had received several Proclamations from cities and the state, including one signed by the Governor of Texas declaring July 11, 2018 to July 19, 2018 to be the Sons of the American Revolution week.
 - SG Warren M. Alter presented the minutes for the 2017 Annual Congress for approval. The minutes were approved.
 - **PG Guzy** reported that the membership of the SAR as of July 10, 2018 was 35,889.
- **PG Guzy** reported that the ExComm recommended that the new SAR logo be approved. They also recommended that the logo be Trade Marked. A motion was made to approve the new SAR logo and to have it Trade Marked. An amendment to the motion was made to change the wording from Trade Marked to the appropriate marks. This motion passed. A vote was then taken on the revised motion and it passed.
- **PG Guzy** then awarded the Gold Good Citizenship medal to James Macingvale or as he is known in Texas as Matress Mac. A second Gold Good Citizenship medal had been approved for Justin James (JJ) Watt for his humanitarian work, but he was unable to attend the Congress. His medal will be awarded at a later date.
- **PG Guzy** brought a motion to amend By-Law 14 by the Chaplain Committee which had been postponed at the Spring Leadership meeting. The Chaplain Committee moved to postpone the amendment to By-Law 14 indefinitely. The motion carried. A report by the Museum Committee stated that the committee had been trying to contact donors or relatives of donors to repatriate items that had been given to the SAR.

The SAR Foundation reported that they had made 500 copies of their Annual Report available for the Trustees. They reported that they had \$700,000 in income during the past year. They then reported that the Foundation had created a new Foundation Donor website. The new Foundation Donor website can be accessed through the SAR website or be found at www.sarfoundation .org. They reported that all money donated through this website would go to the Foundation and not the SAR general fund. After a discussion, the Foundation will modify the website so the Donor can choose which entity they want their donation to go to.

A motion was made by the Virginia Society to change the wording in Volume 1, Constitution, Article III, Eligibility for Membership to read "Any male shall be eligible for membership in the Society being a citizen of good repute in the community, is the lineal descendant, whether by blood or by legally decreed adoption, of an ancestor who was at the time of his last known service demonstrated loyalty to, and rendered active service in the cause of American Independence". The change in wording would allow an adopted child to be eligible to join the SAR through the adopting parents. A motion was made to limit the discussion to 10 minutes equally divided with two for and two against. The motion passed. After the discussion the motion failed.

The second amendment was recommended by the Bylaws Committee to add new sections to define two additional classes of membership described in Bylaw 1 and the Membership Policy (SAR Handbook, Volume III, Page 1).

The proposed new classes of membership were a National Life Member and an Emeritus Member.

This change would clearly list all five classes of membership an define them in one area.

A motion was made to amend the language in the Junior Membership definition from "age birth to eighteen (18) years" to "under 18". The motion passed

A motion was made to postpone the vote on the proposed Bylaw change to the next day in order for the Bylaws committee to review the wording, The motion passed.

A motion was made by the Bylaws Committee to change Bylaw No. 1, Membership; Section 1 to delete the word "residence". The motion passed.

A motion was made by the Bylaws Committee to change Bylaw1, Membership by adding a new Section 6 and renumber the current Section 6 to Section 7.

The change would be to make available to all Regular and Junior members a National Life Membership. The motion passed.

A motion was made by the Bylaws Committee to change Bylaw No 1, Membership; Section 6 (to be renumbered).

In the first paragraph, add a period after Bylaws and delete "except that".

Delete (1)

New (1) wording. A one-time payment in addition to the normal processing fee, in the amount of ten times the annual dues will be collected.

A motion was made to delete the "ten times the annual dues". The motion passed

The motion passed.

The Oklahoma Society proposed and the Bylaws Committee recommended a change to Bylaw 16, Board of Trustees.

The motion was to delete sections (b), (c) and (d) from Section 1.

This would have eliminated General officers (including Vice President Generals), all living former Presidents General, and members of the Executive Committee from being Trustees.

The motion failed

The Bylaws Committee made a motion to revise Bylaw 22, Fees and Dues, Section 6, first paragraph.

The revision would be "A new member shall pay National Society dues for the calendar year in which his application is approved except as follows. Each State Society shall determine when the dues of its members are to be collected; provided, however, that the National Society dues accompanying any application registered on or after September 1 shall be credited to the following year.

The motion passed

The Bylaws Committee made a motion to revise Bylaw 22, Fees an Dues, Section 6: Add a new paragraph.

The new paragraph would be "Notwithstanding the prior paragraph, any new Junior Member application submitted to the National Society in which the new Junior Member will attain the age of 18 prior to December 31st of the year in which the application is registered shall submit National Dues in an amount equal to the Regular Member dues as set by the Annual Congress in recognition of the change in membership status that will occur for this new Junior Member as of December 31st. The motion passed.

The Bylaws Committee made a motion to revise Bylaw 22, Fees and Dues: Add the following Section 8 and renumber the remaining sections

Section 8. Any member may purchase a National Life Membership rather than pay annual dues. Life membership is by virtue of an approved application for enrollment and the payment of a set fee into the Ray Henshaw National Life Membership Fund. All applications for enrollment in the Fund must come through the State Societies. The application and fee shall be sent to the Executive Director of the National Society for processing and entering into the records of the Registrar General. A Compatriot receiving a National Life Membership shall be exempt from further payment of National Society dues.

The motion passed.

The Bylaws Committee made motion to revise Bylaw 22, Fees and Dues, current Section 9.

The revision was "Any member, whose membership has been terminated for any cause, except terminations under the provision of Bylaw No 33, Section 7, may be reinstated by any State Society, in which event such State Society shall immediately report such reinstatement to the National Society, and shall at the same time pay to the National Society the annual dues for such member for the then current year and he shall thereupon be entered on the records of the Registrar General. Reinstatements recorded by the Staff Registrar in accordance with the provisions hereof on or after September 1 shall be credited to the following year.

A motion to amend the wording from "Staff Registrar" to "Registrar General" was made. This motion passed The motion passed.

A motion was made by the Bylaws Committee to revise Bylaw 22, Fees and Dues, Section 6: Add a new paragraph.

The new paragraph will be "The fees and dues for memorial memberships shall be fixed by the Annual Congress. National Society dues for memorial memberships accompanying any application registered on or after September 1 shall be credited to the following year."

A motion was made to strike the second sentence in the new paragraph. The motion passed.

Trustee Report

Back to motion No. 2.

A motion was made to send back to the Bylaws Committee for review. The motion passed.

A motion was made by Treasurer General Jack Manning for the 2018 and 2019 Dues and Fees.

Dues and fees for the year 2018 – 2019 shall remain the same except for a Memorial Application, which shall have an \$80.00 application fee plus \$35.00 annual dues.

An amendment was made to increase the Memorial Application fees to \$350.00 which would go to the SAR Foundation. The motion failed.

The motion passed.

A motion was made from the floor to include the Spanish flag in all future National events. The flag would be the National Flag of Spain. This motion was to begin in 2018 – 2019. The motion passed.

The Nominating Committee put forth a list of nominees for General Officers for 2018 – 2019.

A nomination from the floor was made for PG Larry Guzy to be elected as President General for 2018 - 2019.

The Rules of Congress and the NSSAR Bylaws state that all those nominated from the floor must have submitted the appropriate disclosure forms. PG Guzy submitted those forms when he announced his candidacy at the Fall 2017 Leadership meeting. He later withdrew his name from consideration. He did not submit new disclosure forms prior to being nominated from the floor at Congress.

After discussion, a vote was taken on whether or not PG Guzy had followed the Bylaws for filing for office. That is, the forms he submitted in the fall expired when he withdrew his nomination and were not applicable for the nomination from the floor. By vote the delegates ruled that he had not followed the bylaws and rules.

Copies of the old disclosure forms were resubmitted and the question was raised as to whether PG Guzy might be nominated from the floor again. Treasurer General Jack Manning, sitting in the Chair, ruled that PG Guzy could be nominated again. PG Guzy was nominated from the floor again. A motion was made that the body overrule the decision of the Chair. The motion passed.

Nominations for all officers were then closed.

There were two openings for the SAR Foundation Board, each a three year term. There were two candidates for the two openings, Mike Elston and Sam Powell. Rick Hollis, a board member whose term was expiring was nominated from the floor. A runoff vote by secret ballot was scheduled for the afternoon.

A motion was made to suspend the time limit rule for candidates to address the Trustees. The motion failed.

A list of the uncontested Vice President General's was read. A motion to elect the those VPG's was made and was passed. Contested elections would be included in the afternoon ballot.

A motion to destroy the voting cards for contested elections was made, the motion passed.

President General-elect Alter presented his proposed list of appointees to the National ExCom. A motion was made to elect the appointed members of the ExComm committee, the motion passed.

The list of 2018 – 2019 Trustees and Alternate Trustees was read and revised with additional information from the states. A motion was made to elect the revised list of Trustees and the Alternate Trustees. The motion passed.

A motion was made to elect the General Officers, Vice President Generals and the ExComm Committee members as Trustees was made. The motion passed.

All Trustees and Alternate Trustees were sworn in for the year 2018 and 2019.

The Congress was adjourned on Wednesday, July 18, 2018 at 9:45 am.

2nd Quarter Event April 14 and 15

The Frederica Patriots Day Celebration held on St. Simons Island reminds us of the beginning of the Revolutionary War at Lexington and Concord on April 19, 1775, and the capture of three British ships in the Frederica River on April 19, 1778. The events included a memorial ceremony, a parade, and a Colonial Worship Service. The celebration was sponsored by the GASSAR Historic Sites and Celebration Committee, Marshes of Glynn SAR Chapter and two local DAR chapters. President Don Burdick began the program by describing the two events.

GASSAR Color Guard and the Elijah Clarke Militia presented the Colors Eight elementary students in colonial attire presented historical events; the middle school performed several musical selections. There were sixty wreath presentations in honor of the Minute Men and the Frederica soldiers and sailors. Golden Isle Strummers rode in an antique Fire Engine playing Yankee Doodle. Paul Revere and Sybil Ludington rode their horses.

A Colonial Worship Service was held at Christ Church, Frederica. The Reverend Whit Chapman, a member of the Marshes of Glynn Chapter, led the service with appropriate hymns and sermon with many members of the congregation in colonial attire.

All chapters sponsoring JROTC Units should encourage their Units to participate in the Enhance JROTC (Outstanding Cadet Essay Contest) Program for 2018-2019. The time to contact the JROTC Unit's SMI is right after school starts in late August or early September.

Every SMI in your AO should know the name of the JROTC POC within your chapter. You may want to walk the SMI through the OC Nomination process. Chapter OC Packages need to be sent to me by the 1st weekend in December 2018. If I can assist you in this regard, please contact me. In Aug/Sep, I will again disseminate guidance and directions on submitting a strong OC Nomination Package. Please consider the Outstanding Cadet Enhanced Program and the Bronze ROTC Medal Program to be totally separate programs.

Fifteen Silver ROTC Medal Packages were presented to ROTC cadets at eleven Georgia Universities. Chapter Presidents or their representative from ten GASSAR Chapters present these Medals on behalf of the Georgia Society SAR. Recipients are selected by the ROTC Staff at the University. There is no reason for any chapter to expend funds on a Silver ROTC Medal, as this is a function of the GASSAR ROTC/JROTC Committee. Medal Packages are mailed directly to the University POC (Point Of Contact). If a college contacts a chapter about a medal, please refer them to me. All ROTC Programs do not rate a medal because they are considered a cross-town Unit that falls under a Host Unit (University). Chapters presenting Silver ROTC Medals should report this activity on Form 10.06.0F Chapter Report to BOM and PG/Americanism Report.

Chapters presented Bronze ROTC Medals to JROTC Units within the chapters' AO (Area of Operations). Recipients are selected for this medal by the Senior Military Instructor (SMI). Award Criteria: +Awarded to cadet currently enrolled in the JROTC Program, +A junior (in their 3rd year of a 4 year program or 2nd year of a 3 year program), +Top 10% of the JROTC class, +Top 25% of their class. Chapters should report these presentations on Form 10.06.0F Report to BOM & PG/Americanism Rpt. Sea Cadet Units may nominate a cadet for the Bronze Good Citizenship Medal & there is a Sea Cadet Ribbon (ordered separately) to go along with this medal. If you have questions about the award criteria or the Sea Cadet Program, please contact me.

(NOTE: At the National level we see nominated cadets that do not meet the award criteria. Some are not in the TOP 25% of their class and others did not start in the JROTC Program as freshmen so they fail to meet the third year requirement. Please reiterate the medal criteria with SMI in the early Fall, not at the Unit's Award Ceremony. Under block scheduling a cadet could possibly make up the missed year.)

The Georgia Society SAR supports three DOD (overseas) JROTC Units (Kadena HS Okinawa, Shape HS Belgium, and Vicenza HS Italy).



Flag Respect Committee—Paul Prescott



Committee Objectives

The stated purposes of the Rumbaugh Orations Contest are: (1) to bring American History to the high school student and focus on events of today, (2) to draw an intelligent relationship between the past and the present, (3) to clearly demonstrate freedom of opportunity as a basic right of our national heritage, (4) to place a positive emphasis on the plans of our founding fathers, (5) to emphasize justice under law in the free society, and (6) to illustrate how the Revolutionary War influenced our freedom of expression.

Background Statistics

Since the inception of the Rumbaugh Orations Contest, the Georgia Society is currently tied for 3rd place in having its contests win 1st Place at the National Congress (1967, 1970, 1975, 1977, and 1987). The Georgia Society had not promoted this contest at the State Society level in many years.

We revived the contest in 2008 but had no entry. The 2009 Georgia Society winner, Wells Ellenberg, placed 3rd at the 2009 National Congress in Atlanta, GA. The 2010 Georgia Society winner, Gabrielle Cyphers, was a Finalist at the 2010 Congress in Cleveland, OH. The 2011 Georgia Society winner was Sam Bishop. He competed at the 2011 Congress in Winston-Salem, NC. The 2012 Georgia Society winner, Carley Stamps was a Finalist at the 2012 Congress in Phoenix, AZ. The Georgia Society Orations Winner for 2013, 2014, and 2015 was Jefferson DeMott. He was a Finalist in 2013 (Kansas City, MO) and 2015 (Louisville, KY). In 2014 (Greenville, SC), he did well but was not selected as a Finalist.

The 2016 Georgia Society Rumbaugh Orations winner was Meenal Joshi. She was sponsored by the Joel Early Chapter. Meenal represented our State Society at the National Congress in Boston. She placed as one of six Finalists. Meenal Joshi (sponsored by the Joel Early Chapter) won the Georgia Society Rumbaugh Orations contest for the second consecutive year and advanced to the competition at the 2017 National Congress in Knoxville, TN. She gave a solid performance. However, she was not selected at one of the six finalists. The 2018 winner of the Georgia Society Rumbaugh Orations Contest was Karissa Thomason. She was sponsored by the Button Gwinnett Chapter. Karissa traveled to our National Congress for the NSSAR Rumbaugh Finals Karissa gave a good oration but was not selected to the a Finalist.

Budget Data

The budget for the Rumbaugh Orations Contest provides \$500 to the winner and up to \$1,000 towards expenses to our National Congress and a \$400 prize to the Runner-Up. The State Orations Medal comes out of the Orations budget.

Highlights of the Most Recent Quarter

The Georgia Society Rumbaugh Orations Contest was held on 28 April in Barnesville, GA. Our only contest was Karissa Thomason. Karissa participated in the National Rumbaugh Contest. Karissa gave a good performance but did not advance to the Finals.

Plans for the Next Ouarter

Chapters should begin to make contacts with local schools when the resume in the Fall and advertise this contest.

State and National Competitions

The deadline for Orations entries to be submitted to the Rumbaugh Chairman is 09 April 2019 The date and site of the 2019 Georgia Society Rumbaugh Orations Finals is tentatively set for the last Saturday in April in Barnesville.



Easy Guidelines for the Sons of the American **Revolution Middle School Brochure Contest**

December 15, 1791

Inside Cover: A picture to accompany the introduction. May also contain a brief caption or explanation of the picture. - Brochure Guidelines

Sons of the American Revolution Middle School Brochure Contest

This contest is directed at students in the 6th through 9th grades, depending on which grade year the American Revolution is taught in their educational system. For example, in California, this would be the 8th grade.

Middle School students will create a brochure depicting the theme chosen by the Americanism Committee of the Sons of the American Revolution (SAR).

The Americanism Committee topic / theme is: Choose from any of the five (5) Foundational Documents of the Nation:

- **Articles of Confederation**
- Declaration of Independence
- Constitution
- **Bill of Rights**
- Federalist Papers

PURPOSE & OBJECTIVE

- The brochure should exhibit a knowledge and understanding of American history as well as a personal interpretation concerning the ways in which that history affects contemporary society.
- The objective is for the students to truly internalize and understand the events. surrounding the chosen document and be able to interpret meaning that is relevant in their own life, or in contemporary society in general

Two inner panels: A detailed explanation of the ideas of the student around the theme. This written explanation should provide a systematic argument persuading the reader to the point of view of the author; that is, it should be a persuasive essay. The writing should be clear, well organized, and convincing. These panels may also contain pictures and/or artwork that make the brochure more aesthetically appealing.

Some questions that may be helpful for the students to consider when completing these panels would include:

- What are the lessons for our country within this
- How does this document reflect American society and American values?
- What thoughts do you have regarding the sacrifices made by participants in creating this document?
- What was the outcome of this document and how did this outcome impact American history?
- What motivated the participants to be a part of creating and adopting this document?
- Could you have done what these people did? Would you have done it? - Brochure Guidelines

JUDGING

Brochures will be judged on:

Content Creativity Correctness

A copy of the scoring rubric is included in the Brochure Guide and teachers are encouraged to share it with their students. Prizes & Awards vary by Chapter and State.

GUIDELINES

Brochure size: The brochures should be made from a single 8 1/2" x 11" piece of paper. The paper must be folded according to the instructions provided for the contest. The content of the various panels of the brochure should align with the instructions provided.

Paper thickness: Any common paper so long as the final product can be folded closed as a tri-fold 8 1/2 " x 11" brochure.

Paper color: White paper is most common, but pastel, or color paper is acceptable.

Artwork: Ideas are the most important element in these brochures and the art is merely a means of conveying those ideas. All artwork on brochures that is hand drawn is highly valued, although artwork created by the young person using software is acceptable. Tracing is permissible and simple drawings that represent complex concepts are encouraged for those who may doubt their artistic skills. Do not paste pictures from magazines, books, or off the Internet, or make extensive use of clip art.

Pasting: Pasting of hand drawn art work onto a master is permitted.

Text: The written text is commonly hand printed. Typed text sections (even pasted on) are also permitted. [CAUTION: This must be original text written by the student - not clipped from magazines, books or taken off the Internet.)

Patriot Day

Patriots Day- April 19th marks the beginning of the Revolutionary War at Lexington and Concord. Three years after the "shot heard 'round the world," the Georgia Continental Navy captured three British ships in the Frederica River near St. Simons Island on April 19, 1778. These two events were commemorated during the Fourteenth Annual Frederica Patriots Day Celebration held Saturday, April 14 and Sunday, April 15, on St. Simons Island, Georgia. Larry Dobbs, a reporter with the Brunswick News, created a wonderful account of the Memorial Ceremony – in fact some of the SAR Compatriots said it was the best description of a SAR sponsored event they had ever read. songs, the laying of memorial wreathes, the aforemen-tioned salute of firepower, and a lively parade through the adjoining Pier Village. The local annual event is one of the rare Patriots Day celebrations outside of Massachusetts and Maine. There it is a state-recognized holiday to commemorate the April 19, 1775, anniversary of the Battle of Lexington and Concord and the start of the Revolutionary War.

However, April 19 also was the date three years later of the Frederica Naval Action off of St. Simons Island, when three galleys of the Georgia State Navy outgunned and outmaneuvered three British warships. The local chapters of the Sons and Daughters of the American Revolution honor both historic events in this local Patriots Day celebration.

Those local DARs and SARs put considerable time and energy into making this even happen, but it is nothing compared to the part they play in keeping history relevant in local classrooms. Dressed in Colonial-era attire, these dedicated adults bring history's heroes alive for fourth- and fifth-graders who are being introduced to American history in the classroom.

These youngsters who took part in Saturday's Patriots Day celebration put in several weeks of preparation for their roles. Jimmy Boatwright of the Marshes of Glynn SAR chapter even visited each child at their home, helping them review and research their parts.

Sharon Watson, Nimil's grandmother and a retired Altama Elementary teacher, was proud of her grandson's performance.

"He realized his responsibility and he had fun with it," she said. "I'm so glad (the SAR and DAR) provide this opportunity for our stu-

We fired a total of eight rounds and by 2:00 p.m. the Frontier Days Festival closed down. All three chapters had a great time and look forward to the parade next year.



Our Chapter's History

The Joel Early Chapter was named for Joel Early. He was born in Virginia around 1745 and served in the Revolutionary War as an officer in Virginia's infantry.

Lt. Early was attached to Col. James Pendleton's command which marched from Culpepper Courthouse to Williamsburg where his company was detached from the regiment and stationed along the York River to monitor the activities of the British. His group's reports aided in the defeat of Cornwallis at Yorktown in 1781.

Sometime after the war, Joel moved his family to Georgia, first to Wilkes County and later to Greene County, where he lived until his death in 1806.

One of Joel's sons, Peter Early, served Georgia as state Senator, Judge of Superior Court, Governor, and Congressman in the U.S. House of Representatives. Early County, Georgia was created in 1818 and named to honor the former Governor.

The Joel Early Chapter was chartered September 13, 2002 to serve the southwest corner of Georgia. We have members from most of the counties that were carved from the original Early County that was created in 1818. We also have some members or joint members from Houston County, Alabama and Jackson County, Florida which border our area.

The Joel Early Chapter meets at 6:00 PM on the third Saturday of each month except June and July. Our meetings are held at the Red Hill Center located at 2102 Ash Crossing Road, Iron City, Georgia.

Spring Chapter Meeting


