Georgia On this nineteenth day of October
De Kalb County, eight hundred and thirty two
appeared before the Superior Court held in and
for the county and state of said James Hoodler
a resident of said County and State of Georgia
aged eighty six Against the fifth day of November
next who being first duly sworn deponent
According to laws doth on his oath make
the following declaration in order to obtain
the benefit of the provision made by the act
of Congress passed June the 7th 1832 That
he enlisted in the Army of the United States in
the year seven hundred and seventy eight
with Capt John Stokes in the Battalion Commanded
by Major Blaylock in the Sixth Virginia Regiment
Commanded by Genl. Bissons and under the
Command of Genl. Meadors Lieutenant Major
was one of the副队长 officers of the company
that he served twelve months in this tour
of enlistment that he served six other tours of
about three months under an enlistment
as Private for twelve months that he
served under Capt. G. Green who was promoted
to be then served under Capt. Dixon Cook
Commanded by Colonel Morgan and Lewis that
he resided in the County of Surberburg State
of Virginia that he served a little while longer
in North Carolina that he was in the battle
at Gylford North Carolina which was the
only general engagement he was in during
the war That he started to march from Surberburg
being under the command of Capt. Richard
Wright a Militia officer that joined Major
Garrison's detachment at a short distance

and marched under Major Cunningham to
Washington, crossing at Valley Forge, passed through
Maryland, that he marched after he left
Valley Forge, through Connecticut and
New York and moved about variously according
to the movements of the British army. This was
during the twelve months service.
The honorably relinquishes every claim whatever
to a pension or annuity except the present
and he declares that his name is not on the
pension roll of any agency in any State
known to and subscribed for after the 1st
of May and year aforesaid.

And the said Court doth hereby declare
his opinion that the above named applicant
was a revolutionary soldier and soldier
in the State.

The Deponent further deposes that from his service
of three months and six weeks he had no warrant
but a mere verbal one from the officers commanding
his charge. From his service of three months he
had a written discharge which was given at
Middlebrook, and signed by Deponent & others by
Genl. Washington, which discharge is kept in Depon-
ent's house of no individual name being by whom
he was given and received.

hundred & thirty nine, personally appeared before
the Court of ordinary in & for the State & County
of said Elizabeth Hooper a resident of the
said County & State aged Eighty six years
who being first duly sworn according to law with
on her oath make the following declaration
in order to obtain the benefit of the provisions
made by the act of Congress passed July the 4th
1836. That she is the widow of James Hooper who
was a private in the war of the Revolution, and who
performed such service in said war as are de-
scribed in his declaration now of file in the War
Department at the City of Washington for which
the said James Hooper had at the time of his death
a pension certificate numbered 12,789 and
dated on the 24th day of May 1833 and
signed by Lewis Cass Secretary of war, and con-
firmed by S. L. Edwards Comptroller of
pensions, by which it appears that the said
James Hooper was entitled to receive the sum
of fifty three dollars & thirty three cents ^{per annum} during his
natural life, she further declares that she was
married to the said James Hooper ~~in the year~~
on the sixth day of January in the year 1781, that
her husband the aforesaid James Hooper died
on the 28th day of April in the year 1836 and
that she has remained a widow ever since that
period, as will more fully appear by reference to

the proof hereto annexed. She further states that she was married to the said James Hooper by the Reverend person James Craig in the County of Lunenburg in the State of Virginia from thence she removed to & settled in Franklin County in the said State of Georgia where she remained with ^{her husband &} ~~her~~ family until about fourteen years ago when ~~her~~ husband and ~~she~~ self settled in DeKalb County where ~~her~~ husband continued to live until he died and where she still resides. She further states that there is no person within her knowledge in the State of Georgia by whom she can prove ~~her~~ marriage positively, but there are many persons who have long known her & her husband and have known them always living together as husband & wife. She further states that she had eight children by her said husband & that the eldest a son ~~is~~ ^{is} fifty seven years of age in the month of December last, sworn & subscribed on the day & year above written before us the judges of said court
